



MRSC Club Dinghies Terms of Use

MRSC owns a number of boats for the use by members at any time during the week or weekends. A small fee for hire is required to cover maintenance of the boats. The hire fees are listed below. Fees are not required when undertaking RYA training.

In the event that you did not use the boat due to inclement weather or other circumstance, please email boathire@menegeham.org.uk as soon as possible.

Payment should be made immediately **AFTER** the hire date, by Bank Transfer using the instructions emailed to you on completion of your hire form. This will avoid the need to refund unused hire fees.

1. Dinghies can only be used by Members of the Club, who may be required to produce proof of membership and identity prior to use.
2. Optimists are the only dinghies available for beginners. It is required that hirers of other boats have undertaken training, are competent in sailing the dinghy they wish to hire or are with an experienced sailor or instructor.
3. No club dinghy will be used by the same person or family for a period in excess of 7 consecutive days.
4. In the event of an insurance claim arising in respect of the used boat the user will be liable to pay the excess of £50.
5. At its discretion the Club may require the user to reimburse up to £50 of the cost of any damage to the dinghy or for lost equipment, fair wear and tear excepted.
6. Immediately after use, the dinghy must be put back on their trolley, washed down, with all the rigging packed away correctly and stored in the junior store room. The dinghy must be covered, parked and tied down in the allocated space in the dinghy park.
7. The user may not sail the dinghy other than from the Club site without prior approval of Club RYA Principal.
8. The user of any boat will inform the Boat Hire Secretary immediately after use or as soon as possible via email boathire@menegeham.org.uk of any identified faults or repairs that maybe required for the used dinghy.



Mengeham Race Week Conditions of Hire:

Preference will be given to club members on a first come first serve basis. After a specified date, as advertised in the Notice of Race, non-members will be allowed to book an available boat.

1. This agreement covers hire of club boats for use by competitors for the period of Junior Race Week and is an agreement between the parent/guardian of the competitor and Mengeham Rythe Sailing Club.
2. The Club will require the hirer to provide a deposit cheque against damage of £50 made out to Mengeham Rythe Sailing Club, prior to the hiring in addition to the hire fee. The deposit cheque will be returned at the end of the hire period once the boat has been inspected for damage.
3. The Club will require the hirer to reimburse up to £250 of the cost of any damage to the boat or for lost equipment, fair wear and tear excepted.
4. In the event of an insurance claim arising in respect of the hired boat the hirer will be liable to pay the excess of £50.
5. Immediately after use boats must be returned by the hirer with all the rigging packed away and stored in the Junior store room, as well as boats being washed down, put back on their trolley and parked in the dinghy park. Failure to do so may result in the loss of the deposit.
6. The hirer may not sail the boat other than from the Club site without the approval of the MRSC Mengeham Race Week team.
